

Minutes from the Town of Trenton Town Board Meeting

Date and Time: Tuesday, September 5, 2017, 2017, 7:30 PM

Location: Town of Trenton Town Hall, 1071 Highway 33 East, West Bend, WI 53095

Present: Chairman Joseph Gonnering, Supervisor Ed Doerr, Supervisor Jeff Esselmann, Clerk Cindy Komro, Treasurer Monica Diaz. Attorney Tim Schoonenberg. Chairman Joseph Gonnering asked those in attendance to join in reciting the Pledge of Allegiance. Gonnering called the Meeting to order at 7:31 P.M.

1. Approve Minutes of Town Board Meeting of August 15, 2017:

Ed Doerr moved to approve the Minutes of the Town Board Meeting of August 1, 2017. Jeff Esselmann seconded. Voting in favor: 3. Opposed: 0.

2. Approve Minutes of Special Town Board Meeting of August 21, 2017:

Ed Doerr moved to approve the Minutes of the Special Town Board Meeting of August 21, 2017. Joe Gonnering seconded. Voting in favor: 2. Opposed: 0.

3. Affidavit of Posting:

Chairman Gonnering read the affidavit of posting, stating that notice was properly posted prior to the meeting on the Town Bulletin Boards and sent to West Bend Daily News and WMBZ & WBKV Radio.

4. Comments and Questions from the Audience:

- Town Resident Milton Holl, 1800 Decorah Road, asked about the change in his property's zoning. He is concerned about the restrictions on the structures he can build. Chairman Gonnering discussed the Town of Trenton zoning rules and the Town-wide rezoning process that occurred several years ago, related to the 2035 Comprehensive Plan.
- Pam Serafin, 6051 Sand Drive, asked about the definition of a privacy fence. Attorney Tim Schoonenberg explained the Town ordinances and encouraged her to contact Zoning Administrator Barbara Davies for further direction.

5. Review and Accept Agenda:

Jeff Esselmann moved to approve the agenda as presented. Ed Doerr seconded. Voting in favor: 3. Opposed: 0.

8. Correct Spelling of Mapledale Road:

9. Stop Signs at Paradise Drive and Church Road:

Chairman Gonnering explained the concern regarding the intersection. Ed Doerr moved to amend Town Ordinance §368-9 to add a stop sign on South Church Road at Paradise Drive (north-bound lane). Jeff Esselmann seconded. Voting in favor: 3. Opposed: 0.

10. Schedule Special Meetings to Review 2018 Town Budget:

Clerk Cindy Komro proposed holding special meetings to discuss the Town Budget: Friday, September 15 at 8:00 AM, Tuesday, September 19 at 6:00 PM and Tuesday, October 3 at 6:00 PM.

11. Deer Removal Services Contract:

Chairman Joseph Gonnering reviewed the proposal from Wayne Wehrwein. Ed Doerr moved to approve the contract for deer removal services with Wayne Wehrwein at a cost of \$30 per deer. Jeff Esselmann seconded. Voting in favor: 3. Opposed: 0.

Treasurer Monica Diaz reported that the property tax payment was received from the County.

Clerk Cindy Komro reported that the Town Crier was sent for publication.

Supervisor Ed Doerr reported on a resident call regarding a trash can repair.

Supervisor Jeff Esselmann had nothing to report.

None.


17. Ordinances, Resolutions, Reports or Recommendations Already Pending Before the Town Board:
