

Minutes from the Town of Trenton Town Board Meeting

Date and Time: Tuesday, March 19, 2019, 7:30 PM

1. Approve Minutes of Town Board Meeting of March 5, 2019:

8. Ordinance Z2019-02-01, Side-Yard Setbacks on Lots with Lake Frontage:

Zoning Administrator Barbara Davies presented the details of the proposed ordinance. Ed Doerr moved to approve Ordinance Z2019-02-01. Jeff Esselmann seconded. Voting in favor: 3. Opposed: 0.

9. Ordinance Z2019-02-02, Amending the Comprehensive Plan of the Town of Trenton and Amending the Zoning Map of the Town of Trenton:

Zoning Administrator Barbara Davies presented the details of the proposed ordinance. Jeff Esselmann moved to approve Ordinance Z2019-02-02. Ed Doerr seconded. Voting in favor: 3. Opposed: 0.

10. Ordinance Z2019-02-03, Accessory Uses and Structures:

Zoning Administrator Barbara Davies presented the details of the proposed ordinance. Jeff Esselmann moved to approve Ordinance Z2019-02-03, with one modification from the recommended ordinance: increasing the height limitation from 28 feet to 35 feet for CES-10. Ed Doerr seconded. Discussion followed. Voting in favor: 3. Opposed: 0.

11. Scheunemann Preliminary Plat Approval:

Zoning Administrator Barbara Davies presented the details of the preliminary plat for property located north of Terry Jak Drive and east of Shady Lane Road in the Town of Trenton. Ed Doerr

moved to approve the preliminary plat for Scheuneman's Evergreen Acres. Jeff Esselmann seconded. Voting in favor: 3. Opposed: 0.

12. Operator's License Application: Kristian Butzin, West Bend Lakes Golf Club:

Police Chief Joe Gabrish recommends denial of the Operator's License, based on record check. Jeff Esselmann moved to deny the Operator's License Application for Kristian Butzin. Ed Doerr seconded. Voting in favor: 3. Opposed: 0.


18. Ordinances, Resolutions, Reports or Recommendations Already Pending Before the Town Board:
