

Minutes from the Town of Trenton Town Board Meeting

Date and Time: Monday, April 1, 2019, 2:00 PM

Chairman Joseph Gonnering Chairman Gonnering invited those in attendance to join in reciting the Pledge of Allegiance. Gonnering called the Meeting to order at 2:01 P.M.

1. Approve Minutes of Town Board Meeting of March 19, 2019:

None.


15. Ordinances, Resolutions, Reports or Recommendations Already Pending Before the Town Board:
