

Minutes from the Town of Trenton Town Board Meeting

Date and Time: Tuesday, September 17, 2019, 7:30 PM

Clerk Cindy Komro presented the resolution. Ethan Hollandberger from Washington County commented on the request to pursue a Joint Library with West Bend Community Memorial Library. Joe Gonnering moved to approve Resolution 2019.09.02. Jeff Esselmann seconded. Voting in favor: 2. Opposed: 0.

Clerk Cindy Komro recommended following the City of West Bend Trick or Treat Hours, which are from 4:00-6:00 PM on Saturday, October 26. Joe Gonnering moved to set Town Trick or Treat Hours to Saturday, October 26, 4:00-6:00 PM. Jeff Esselmann seconded. Voting in favor: 2. Opposed: 0.


