Zoning Administrator Barbara Davies explained that Mike Komro, as Alternate Board of Appeals member, is willing to serve as a regular member. Ed Doerr moved to approve appointment of Mike Komro to Board of Appeals. Joe Gonnering seconded. Voting in favor: 2. Opposed: 0.

None.


