

Minutes from the Town of Trenton Town Board Meeting

Chairman Joseph Gonnering invited those in attendance to join in reciting the Pledge of Allegiance. Gonnering called the Meeting to order at 7:31 P.M.

1. Approve Minutes of Town Board Meeting of November 5, 2019:

Joe Gonnering moved to approve the minutes of the Town Board meeting of November 5, 2019. Ed Doerr seconded. Voting in favor: 3. Opposed: 0.

None.


16. Ordinances, Resolutions, Reports or Recommendations Already Pending Before the Town Board:
