

Minutes from the Town of Trenton Town Board Meeting

Date and Time: September 7, 2021, 7:30 PM

Present: Chairman Joseph Gonnering, Supervisor Ed Doerr (via teleconference), Clerk Cindy Komro.

Chairman Joseph Gonnering asked those in attendance to stand and recite the Pledge of Allegiance. Gonnering called the Meeting to order at 7:30 P.M.

1. Approve Minutes of Town Board Meeting of August 17, 2021:  
Ed Doerr moved to approve the minutes of the Town Board meeting of August 17, 2021; Joe Gonnering seconded. Motion carried 2-0.
2. Affidavit of Posting:  
Chairman Gonnering read the affidavit of posting, that notice was properly posted prior to the meeting on the Town Bulletin Board and the Town official website and was also sent to the Washington County Daily News and WIBD Radio.
3. Comments and Questions from the Audience:  
George Spaeth, 1791 Wallace Lake Road, commented on water sitting on the side of the road.
4. Review and Accept Agenda:  
Ed Doerr moved to approve the agenda as presented; Joe Gonnering seconded. Motion carried 2-0.
5. Reports from Town of Trenton Police and Washington County Sheriff's Departments:

6. Culvert Waiver Application: Dennis Gutbrod, 7115 Shady Lane Rd (new construction):  
Ed Doerr moved to approve the culver waiver application for 7115 Shady Lane Rd, with the stipulation that if the road gets widened or ditched, a culvert would be required at that time; Joe Gonnering seconded. Discussion followed. Motion carried 2-0.
7. August Bank Statement Reconciliations:  
Joe Gonnering moved to approve the August bank statement reconciliations; Ed Doerr seconded. Motion carried 2-0.
8. Change Trenton Website Domain Name:  
Clerk Cindy Komro explained that the Wisconsin Elections Commission will soon require all email correspondence to go to a ".wi.gov" or ".gov" domain, to improve security for elections correspondence. Ed Doerr moved to change the Town of Trenton domain name to townoftrenton.wi.gov, if available; Joe Gonnering seconded. Motion carried 2-0.
9. Adopt General Records Schedule:  
Ed Doerr moved to adopt the General Records Schedule approved by the Wisconsin Public Records Board on August 27, 2018; Joe Gonnering seconded. Discussion followed. Motion carried 2-0.
10. Authorize Town Employees to Attend Seminars: Public Works WCMLE (Formerly CONEX):  
Joe Gonnering moved to authorize two DPW employees to attend the WCMLE conference; Ed Doerr seconded. Motion carried 2-0.
11. Department Reports:  
Clerk Cindy Komro reminded the Board that the Electronic Waste Event is on Saturday, September 11 from 8:00 – noon at the Town Hall yard. Komro updated the Board on the audit/review.

Chairman Joe Gonnering reported on DPW activity, including ditching and mowing work.


12. Payment of Bills:
