REQUEST FOR BID

NOTICE IS HEREBY GIVEN by the undersigned that sealed bids will be received in the office of the Town Clerk, 1071 Hwy 33E, West Bend, WI 53095 until 7:30 PM on September 21, 2021, for the work and materials to repair or replace the following roofs at the Town of Trenton, all located at 1071 Hwy 33E, West Bend, WI:

- 1) **Roof covering the garage portion of the Town Hall building:** Prepare surface, inspect roof and fasteners, seal seams, apply R2016 to entire roof surface, and clean and repair gutters. Remove and seal three penetrations. Include product warranty options for 10 years and 15 years.
- 2) **Roof covering salt shed and attachments:**
Option A: Metal Roof: Install steel roof material to existing rooflines. Include product and labor warranty options.
Option B: Asphalt Shingles: Remove and replace shingles with minimum 30-year asphalt shingle. Color options at discretion of Town Board.
- 3) **Roof covering concession stand in Town Park:**
Option A: Metal Roof: Install steel roof material to existing rooflines. Include product and labor warranty options.
Option B: Asphalt Shingles: Remove and replace shingles with minimum 30-year asphalt shingle. Color options at discretion of Town Board.

Bidder may bid on any or all roof covering work and should be listed separately.

Notes:

A Certificate of Insurance is required listing the Town of Trenton as an additional insured showing the statutory limits for workmen's compensation coverage; \$2,000,000 general liability coverage; and \$2,000,000 umbrella coverage. The Bidder hereby agrees to indemnify, defend and hold harmless the Town of Trenton, its elected and appointed officials, officers, employees, agents, representatives and volunteers, and each of them, from and against any and all suits, actions, legal or administrative proceedings, claims, demands, damages, liabilities, interest, attorneys' fees, costs, and expenses of whatsoever kind or nature in any manner directly or indirectly caused, occasioned, or contributed to in whole or in part or claimed to be caused, occasioned, or contributed to in whole or in part, by reason of any act, omission, fault, or negligence, whether active or passive, of the Bidder or of anyone acting under its direction or control or on its behalf, even if liability is also sought to be imposed on Town of Trenton, its elected and appointed officials, officers, employees, agents, representatives and volunteers. Also include copy of Form W-9. Bids must be received no later than Tuesday, September 21 at 7:30 PM. Bids will be publicly opened at that time in the Town Board Room of the Municipal Building located at 1071 State Hwy 33E, Trenton, Wisconsin. Award will be made to the lowest, best, most responsible bidder, or the bid most advantageous to the Town. The Town reserves the right to reject any and all bids.
