



Property Tax



Pay your property tax bill in one of the following ways:

BEFORE JANUARY 31:



- ✓ Mail check in enclosed envelope to Town of Trenton, PO Box 259, Newburg, WI 53060
- ✓ By placing in the Town of Trenton Drop Box located under the bulletin board at the Town Hall, 1071 Hwy 33E, West Bend (available 24 hours/day)
- ✓ In person by cash, check, credit card or eCheck (*fee will apply for credit card and eCheck payments*) at the Town Hall on Wed & Thurs in December and January from 10am-1pm
- ✓ By check inside the State Bank of Newburg, 300 Congress Dr, Newburg, WI 53060 during normal business hours, Mon-Fri 9-5 and Sat 8:00-noon (TAXES ONLY, NO DOG LICENSES)
- ✓ Online using credit card or eCheck (*fee will apply*) through a link on our website's Property Taxes page at www.townoftrenton.info
- ✓ By phone using credit card or eCheck at 888.604.7888 (*fee will apply*)

AFTER JANUARY 31:

- ✓ By mail to Washington County Treasurer, 432 E Washington St, West Bend, WI 53095-7986
- ✓ Online or by phone (*fee will apply*) through Washington County—visit www.co.washington.wi.us, Departments/County Treasurer

Provide a self-addressed, stamped envelope to receive a mailed receipt



Indicate mailing address changes on payment stub



Enter ALL information on Dog License Application (include proof of rabies)



Note escrow payment amounts

- ✓ If your escrow check is less than the amount due, write a separate check for the balance
- ✓ If your escrow check is for more than the amount due, refunds of \$1 or more will be issued within 21 days



Look online to review payment and print receipt

- ✓ Go to LandRecords.co.washington.wi.us/LandRecords or find link on our website
- ✓ Search by choosing T11-Town of Trenton in drop down menu, then typing your property address NUMBER ONLY



Staple your check to your payment stub



Pay taxes at the Town Hall after January 31

- ✓ Payments made after January 31 MUST be made at the County Treasurer's Office, 432 E Washington St, West Bend, WI 53095-7986
