Pay your property tax bill in one of the following ways:

BEFORE JANUARY 31, Pay Town of Trenton:

- ✓ Mail check in enclosed envelope to **Town of Trenton, PO Box 259, Newburg, WI 53060** 
- ✓ Place in Drop Box at the Town Hall, 1071 Hwy 33E, West Bend (available 24 hours/day)

- ✓ By phone using credit card or eCheck (*fee applies*) —Call County at 262.335.4324

Enter ALL information on Dog License Application (include rabies certificate)



Note escrow payment amounts

- ✓ Include a separate check if escrow check is short
- ✓ Expect refunds of \$1 or more within 21 days if escrow check is over amount due
