

Minutes from the Town of Trenton Town Board Meeting

Date and Time: January 3, 2006 – 7:30 P.M.

Chairman Joe Gonnering called the Meeting to order at 7:43 P.M.

Gonnering asked the citizens in attendance to join in saying the Pledge of Allegiance.

Approval of Minutes – Town Board Meeting of 12/20/05:

It was moved by John Norman and seconded by Joe Gonnering to approve the Minutes of the Town Board Meeting of 12/20/05 as printed. Carried unanimously.

Comments and Questions from the Audience:

Mike Komro asked about the status of a cleanup of a property on Decorah Road.

Accept/Review Agenda:

It was moved by John Norman and seconded by Ed Doerr to accept the Agenda as printed. Carried unanimously.

Petition for Acceptance as a Town Road – Jubilee Avenue (Tabled 12/20/05):

Engineer Burt Naumann has not yet completed the final inspection of the road. It was moved by John Norman and seconded by Ed to table action on this petition to the Town Board meeting of 1/17/06. Carried unanimously. Carried unanimously.

Approve 10th Amended Agreement – Operation of the Mid-Moraine Municipal Court:

Chairman Joe Gonnering told the Board that the current members of the Municipal Court must vote to approve acceptance of new members to the court. The Village of Fredonia has expressed an interest in joining the Court. It was moved by Ed Doerr and seconded by John Norman to approve the admission of the Village of Fredonia as a member of the Mid-Moraine Municipal Court. Carried unanimously.

Treasurer Monica Diaz reported that she has started using the Peachtree software for accounting and payroll. Tax collections have been busy.

Chairman Joe Gonnering reported that he had filed nomination papers to run for District 15 County Supervisor today. Gonnering read correspondence from County Board Chairman Miller re: town/village/city photos to be

placed in the new courthouse addition. The County is asking for \$500 from each municipality to defray the cost of printing and posting the photos from the various municipalities. Gonnering will contact Ken Miller. There have not been many snow/ice callouts lately, so sand/salt usage is down.

Supervisor Ed Doerr reported that the frost is out of the ground, so the weeds will probably appear soon.

Supervisor John Norman reported receipt of a letter from SBC, requesting that Town officials contact SBC to discuss all possibilities offered by SBC in the event that the Town is considering setting up its own wireless service.

Payment of Bills:

It was moved by John Norman and seconded by Ed Doerr to approve payment of bills totaling \$65,895.86, payroll of \$13,028.91, and property tax overpayment refunds of \$12,296.47. Carried unanimously.
